Called to Order at 8:35 a.m.

- A. Review and Approve January Minutes-Jack moved, Dick seconded
- B. Review and Approve Treasurer's Report and membership Report
 Ben moved to approve Treasurer's report, Jack seconded
 Motion made for \$300 donation to Rivers and Lakes Fair, Micki moved Janet seconded
- C. President's Report
 - Canceled February Meeting
 - Bruce wondered whether there were any issues with that cancellation. Consensus was there was no issue and discussion ensued that we could permanently skip some winter meetings but we agreed that having the meetings scheduled as usual makes sense and if we need to cancel we can do that
 - b. Annual Meeting
 - Date will be June 24th
 - Various members up for reelection, we have one director opening
 - Kathy pointed out that the BSLA was established 25 years ago, on March 13, 2017, and that we should commemorate this at the annual meeting
 - D. Old Business
 - a. MNCOLA Survey Sandy Lake Area Watershed Management
 - Discussed the Action Agenda items. Most favored number 1 on the list-Enhance
 AIS inspection and decontamination. There was also significant discussion
 regarding septic system regulation, ensuring sustained funding for the U of M,
 and increasing fines
 - b. Status of AIS Funding and Detectors
 - Christopher discussed the AIS 60-minute training concept and all agreed that having that basic training as a lake association sponsored event would be a good idea. Question came up about whether this could be part of the annual meeting agenda. Agreement was that these should be two separate events, one being scheduled early summer and put on by the DNR, and a short educational session put on by County AIS folks at the annual meeting. May 20th or May 6th at 10am were proposed as possible dates. Christopher will look into
 - Christopher discussed the data he has received from Steve Hughes regarding inspections, inspection hours and results from the 2016 season. 16 accesses

were inspected total in Aitkin County and there were no mussel sightings. There were however velagers found in Round Lake north of Mille Lacs during a water test. The numbers showed that about 10,000 inspections took place which equate to about one per hour. Discussion had regarding whether we should go above our 420 hours in the grant. Above that threshold commits us to a 50/50 share as opposed to the 90/10 in the grant itself. Christopher discussed that he will discuss with Steve Hughes the concept of expanding the inspection hours by having them start earlier in the day, and if that is not viable, then perhaps asking that the start time be shifted to earlier in the day to ensure we are covering the busier mornings when more boats are being launched, focusing primarily on Friday through Sunday mornings

 - Bruce mentioned community education opportunities, Micki pointed out that two U of M classes are scheduled and coming up

- b. Particular Member-Benefactor Matter
 - Has been donating, as a benefactor, via the United Way for quite some time, and should be acknowledged as Lifetime Member
 - Kathy will be in touch with her to ensure our recognition of her/their efforts

F. Director's Reports

- a. Janet Hill
 - Discussed efforts regarding the improvement of Internet connectivity here in Aitkin County. She participated in a well-attended event involving the Blandin Foundation (who is offering community grant funding for this purpose) involving community stakeholders passionate about the issue of poor Internet options in our area. Projects discussed included creating "hot spots" in places like Palisade, McGregor, Internet on school buses. This would involve erecting more towers in our township for this purpose. Ron Smith mentioned that the Township favors this concept.
 - Guest speaker, Grant, spoke on various options for Internet and the various problems with what exists now, including poor service from Frontier. Part of problem is that Frontier is not investing in improving its own technology. Grant has a background in IT. Grant asked BSLA and Township if we would support this cause by working with Frontier in pricing out best options for improving their technology. The notion was discussed that the area is becoming a less desirable place to live and own property due to how lacking we are in Internet service compared with other areas. The specific role that we would be taking

- on would be to help apply pressure on Frontier to apply for available grant funds for this purpose
- Janet discussed her experience at the MNCOLA meeting regarding efforts statewide regarding AIS, and particularly at Lake Sylvia to decontaminate boats with Hydrogen Peroxide. Ben mentioned outreach via coasters with BSLA and AIS information, Ben will bring a sample to next meeting

b. Kathy Beatty
